Mindlink School of Metaphysics Terms and Conditions

1. Terminology

In these conditions, except where the context otherwise defines:

Student means any individual or other body or person for whom the Programme is provided.

'Company' means Mindlink School of Metaphysics (MSM).

'Programme' means a programme of study by distance learning offered by the Company.

2. Applications

Students wishing to join a MSM Programme must complete an application form and submit with other necessary documentation as specified by the MSM. The Student must satisfy the entry requirements for the selected Programme and provide appropriate evidence, in order to be considered.

The Company understands that a Programme can be studied from anywhere in the world.

The Student understands and accepts that should they seek out or receive support for their Programme from any third party without the prior written permission of the Company then this will result in immediate termination of their Programme.

3. Overseas students

MSM is able to accept international students. Fees may vary and acceptance will depend upon the Programme availability.

4. Programme fees

MSM Programme fees may not include registration or membership of relevant professional bodies. Please refer to MSM fees.

Payment is done either by of the full fee, minimum deposit or monthly subscription fees.

MSM reserves the right to cancel the issuing of Programme materials, tutor support and assessment in the event of non-payment of Programme fees.

MSM reserves the right to change the fees without prior notice. Programme fees charged will be those set at time of application.

Programme fees on enrolment are guaranteed to be offered at a fixed rate for the minimum duration of the client's study which is normally 1 year for an MSM Level 1.

5. Programme duration and content

Tutor support will be available for the duration of a Programme as detailed on the MSM website. After this time tutor support will cease except by arrangement.

Programme materials

Student Programme materials in conjunction with tutor support are designed to provide the information required to successfully complete the Programme. Additional reading recommendations are available for areas of special interest to Students and these should be purchased by the Student separately as appropriate.

A timetable is designed to help the Student to prepare for assessment. It is recommended that Students follow the guidelines given. If Students are not able to meet assessment deadlines they must contact their tutor or the MSM office, immediately. Failure to meet assessment deadlines may result in an additional fee, depending upon the Programme studied.

Assignments should be returned to the Student's tutor or programme co-ordinator as appropriate, these will be marked and relevant feedback provided. Resubmission of assignments may be possible, at the discretion of MSM.

6. Cancellation

If Students are not completely satisfied during the first 60 days from first access of the programme then MSM will refund in full the Student fees paid unless they have sat or submitted an assessment. Students may also cancel under these terms:

Cancellation within first 60 days:

A full refund of the Programme fees paid will be provided during the first 30 days from first access of the programme. This refund is not available to students who have sat or submitted an assessment. The refund will be subject to the return of any programme material in original condition, received by MSM at the time of the refund request. The client must meet any expenses incurred in returning materials, directly. The refund request must be made in writing to MSM.

Promotional offers

Refund of goods purchased under a promotional offer will be based on the terms of the promotional price.

Short online courses

For all short online courses no refunds will be given. This does not affect your statutory rights.

Modular courses

For all modular courses the 60 day money back guarantee is only applicable to the first module of the course.

7. Programme transfer

Students who wish to apply for a transfer to another programme through MSM should complete and submit a transfer form. If the request is successful then a €25 Transfer Fee will fall due immediately and must be paid to MSM prior to the transfer being agreed. Additionally, if the fees of the new programme are lower then no discount or refund will be due to the student. If the fees of the new programme are higher then the difference must be paid prior to the transfer being agreed.

8. Termination and withdrawal of programmes

The Student understands and accepts that the Student will not be eligible to apply for or enrol on any Programme for one year following withdrawal from any Programme.

The Student understands and accepts that the Company reserves the right to modify, withdraw or terminate any Programme at any time without prior notice.

The Student understands and accepts that the Company reserves the right to terminate any individual's Programme at any time and without prior notice.

The Company is not obliged to provide reasons for termination or withdrawal of any Programme to any parties.

9. Monthly Payments

If monthly payments are not maintained, access to your course will be restricted and students will be automatically reverted to modular payments. The company reserves the right to withdraw this offer at any time and any final decisions on applicability remain with the Company.

10. Communications opt-in

By registering you consent to receive communications from MSM using your registered details, for the time being. Any personal data collected through our websites or offices will be treated in accordance with the Data Protection Act 1998. Please note your personal data will be transferred to the Mindlink Foundation which have committed (by way of contractual undertakings to us) to the same levels of protection for your personal data as we are required to adhere to under the Data Protection Act 1998.
